COSTUME RENTAL AGREEMENT

1. Reservations are strictly on a first-come first-served basis.
2. You must be at least 18 years of age to sign the rental contract.
3. You must present one valid form of identification: Driver's License, Employer I.D., or Military I.D.
4. Costume Rental prices quoted are for a 2-day period. Additional rental charges will be incurred for Lessor approved early pick-up or extended rental time period
5. Costumes may be reserved by paying full rental price plus tax at time of reservation. If not previously reserved, rental price plus tax must be paid at time of pick-up.
6. Costumes must be picked up and returned according to the "DATE OUT" and "DATE DUE IN" stipulated on the invoice. Late return fees are charged by the day as stated below until returned A police theft report will be filed after one week past date due in of non return of costumes and civil charges filed after one month past date due in.
7. Lessee acknowledges receipt of the described personal property. The parties agree that the property was inspected by lessor and personally examined by the lessee at the time of delivery and acceptance by lessee and that the property was in good and serviceable condition.
8. Title to the rented property is and at all times shall remain with lessor. Only the parties hereto and such persons whose names are endorsed hereon are authorized to use said property and lessee will not permit said property to be used by any other person without the consent of the lessor. Property may not be altered.
9. Upon termination of this Agreement, lessee will promptly return the rented property and all accessories and parts belonging thereto to the lessor at the lessor's place of business, in the same condition in which the property was received (ordinary wear excepted), and agrees to pay for any damage to or loss of such property while in the possession or control of lessee, hereunder. In the event that the lessor must resort to litigation to recover damages caused to or loss of such property, lessee also agrees to pay lessor's reasonable attorney fees and court costs.
10. Rental charges cannot be applied against replacement fees of lost articles or cost of repairs of damaged articles.
11. Lessee hereby waives and releases lessor from all claims for injuries, allergies, or damages to lessee arising out of the use of said property by lessee. Lessor does not make any warranty or representation as to the suitability, safety, or fire-resistant qualities of any costume, nor to the non-allergic propensities thereof, and all such material is worn and used at the lessor's own risk. Lessee does hereby waive, release and discharge lessor for any and all claims for damages of any kind by lessee or third persons arising from the use of any property by lessee.
12. If Lessee cancels a reserved rental, a Cancellation Fee will be charged. Said Cancellation Fee and taxes will be deducted from Rental Amount Paid.

FEE STRUCTURE

Cancellation Fee:	\$25.00 for reserved rentals from September 1 - October 31 \$5.00 for reserved rentals from November 1 - August 31
Late Returns:	\$10.00 per day until returned
Damages:	\$5.00 and up according to the degree of damage
Lost/Non-Returned Items:	Assessed at Cost of Replacement
Returned Check:	\$25.00
